

INSTRUCTIONS

1. Please use the following Statutory Declaration Form to provide this Office with an unaltered copy of an original document: birth certificate, certificate of legal change of name, marriage certificate, divorce decree, Record of Landing, Permanent Resident Card, Canadian Citizenship card, Canadian passport, work authorization or other document requested by this Office or that you wish to provide to support your application for teaching authority.
2. The blank line of item No. 1. on the declaration form allows you to fill in the name of the document that has been requested or that you wish to provide to support your application for teaching authority.
3. You will need one Statutory Declaration Form for each unaltered copy of an original document you submit.
4. Please note that you also are required to provide the Commissioner for Oaths or Notary Public with picture identification to be submitted as Exhibit B under item No. 2. of the Form.
5. Two signatures are required on the form. The Notary Public or Commissioner for Oaths is to sign on the lower left side, below the date. The blank line to the right is intended for your signature.
6. If you do not currently reside in the province of Alberta, but live in Canada, and will be submitting a statutory declaration, please provide the attached statutory declaration form to the Commissioner for Oaths or Notary Public where you reside to use as a template.
7. If you currently reside outside Canada and will be submitting a statutory declaration, please provide the attached statutory declaration form **to a Notary Public** where you reside to use as a template.

Under section 131 of Canada's Criminal Code, all persons making a false declaration are punishable by up to 14 years imprisonment.
